Demographic Characteristics of The Sample

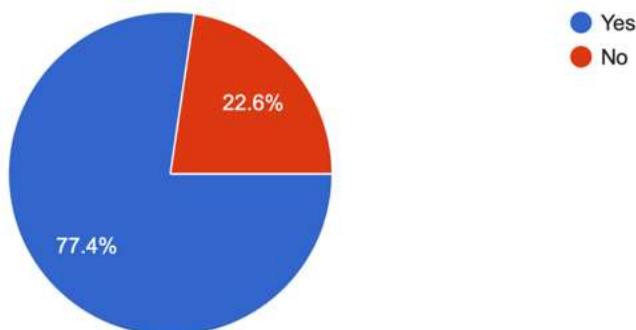

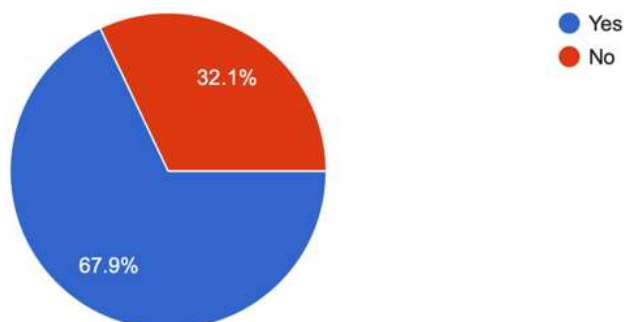
1. Are you aware of the National Education Policy – 2020 (NEP)?

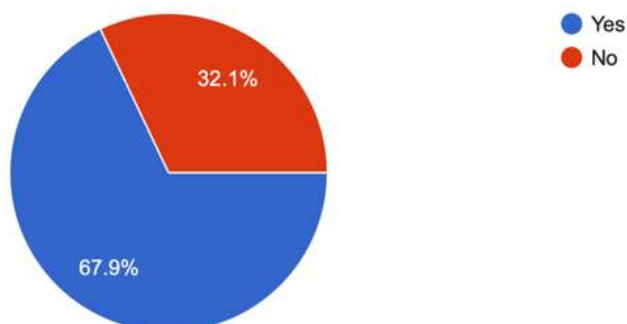
2. Does the National Education Policy allow for Political consensus and collaboration?

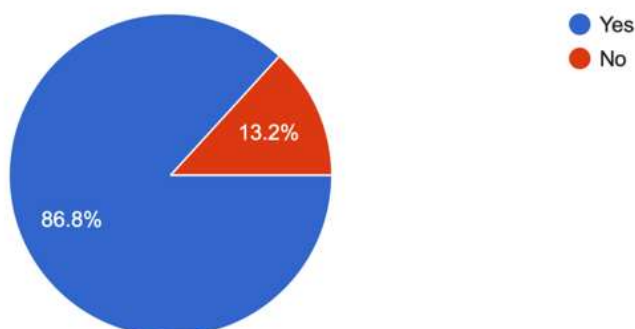


3. Does the NEP have key to India's continued ascent and leadership on the global world?

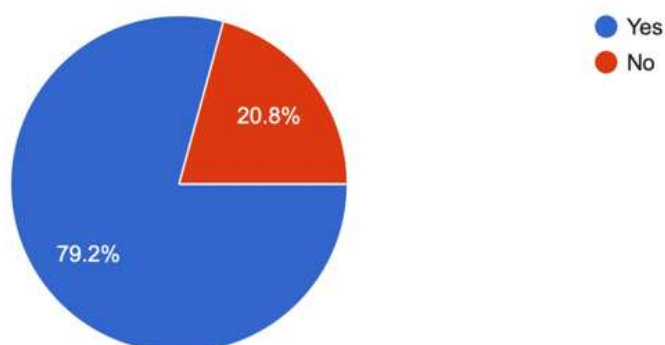
