Tinea is common superficial dermatophytic infection caused by fungus especially in groins region. A 45 year old male reported with tinea cruris from 7 to 8 month. A complete case history was taken and after repertorization on the basis of totality Sulphur in 200 potency was selected. Case is closely followed for almost 3 months after start homoeopathic treatment, which shows the effectiveness of Constitutional Homoeopathic Medicine in the treatment of Tinea Cruris.

Introduction:

Tinea is the superficial fungus infection. Tinea cruris is also known as JOCK ITCH is an infection in genital, pubic, perineal and perianal skin caused by pathogenic fungi known as dermatophytes. Dermatophytes are on aerobic fungus that produces proteases that digest keratin and allow colonization and infection of stratum corneum of skin, the hair and the nail.

More than million of healthy as well as immune compromised are victims of the infection worldwide. Tinea cruris affected 20 to 25% of the world population. It occur in epidemic proportion in condition where there is high rate of humidity, over population and poor hygiene condition.

They generally gets worse during the summer and the rainy season and tend to get heal spontaneously during winter.

Tinea cruris is caused by dermatophytes belonging to three genera of fungi.

- 1. Epidermatophyton: Its affects only human skin. There is only one important species E. flaccosum.
- 2. Microsporum: The important species are M.audounii and M.cannis and Lanosum.
- 3. Trichophyton: It is more virulent than the other. It affects the hairs, the glabrous skin, as well as the nails. It includes both the human and animal species. The important species are T.rubrum and T.mentago.

Types:

Different types of fungal infection are named:

- 1. Tinea Pedis: Tinea of feet occurs due to hyperhidrosis of soles and occlusive foot wear.
- 2. Tinea Mannum: Tinea of palms or hands, unilateral, well define plaques of palm with well accumulation of scales in crease.
- 3. Tinea Barbae: Fungal infection occurs in the beard. It is present with perifolicular pustules, papules, erythema, and seropurulent discharge. It caused cicatricial alopecia on healing.
- 4. Tinea Corporis: Annular/aracute lesion with clearing in centre and active periphery affects glabrous skin except palms, soles and groins.
- 5. Tinea Faciae: Annular scaly patches on cheeks of children.

6. Tinea Capitis: Dermatophytosis occurring in the hairs and the hair follicles. Tinea capitis is commonly seen in children than the adults. The degree of inflammation depends on the strain of fungus.

Case study:

A 45 year old married Hindu male having dark complexion belonging from middle socio-economic status reported in OPD on 9th April 2022, with complaint of severe itching+4 with burning in inner thigh and groin region since 7 to 8 month. Redness is present after severe scratching. Small macular eruptions are present. No discharge. Complaint are aggravated in warm weather and after perspiration, ameliorated after apply ointment.

Discussion:

Considering the age and susceptibility of the patient 200c potency of sulphur (single dose) was prescribed. This medicine brought about, marked improvement in the skin complaint and general condition of patient. The intensity of itching, burning and eruption are reduced. Assess the clinical improvement based upon DLQI score and photograph of skin lesion show that the skin complaint has improved. Also irritability and short tempered behavior of patient was improved. This show that constitutional homoeopathic medicine is effective in improving of patient health in most easy and harmless way.

Conclusion:

Homoeopathic constitutional medicine selected on the basis of Law Of Individualization are effective in giving symptoms relief to patient and improving the quality of life of patient assessed by DLQI score. In this case patient improved gradually after prescription of sulphur 200 in centesimal scale. The patient

showed improvement in beginning which proved right selection of medicine.

This case shows positive role of individualized homoeopathic medicine in effective treatment in case of tinea cruris.
